NOTICE FOR REPORTING OF CANDIDATES FOR FINAL ADMISSION INTO 1ST YEAR M.TECH

The candidates allotted for admission in CAPGS,BPUT,ODISHA,ROURKELA for M.Tech are instructed to report in Academic Block on **8**th **and 9**th **August,2016**, **at 10AM** in **BPUT,ROURKELA** for final admission.

The admission fees should be deposited in form of Demand Draft issued through any nationalised bank in favour of "BIJU PATNAIK UNIVERSITY OF TECHNOLOGY, ODISHA" payable at ROURKELA. The fees amount is RS. 33,400/- for M.Tech programmes. All the fees must be deposited in one instalment in form of D.D. at the time of reporting for final admission. Part fee payment at the time of admission is not allowed.

NOTE: Class start date will be notified on the date of admission (Likely to be from 10th August 2016 onwards).

The candidates are required to submit the following documents along with all original relevant documents for verification purpose.

Documents Required at the Time of Teporting.

- 1. All Certificates and Mark Sheets from 10th onwards including College Leaving Certificates, Conduct Certificates and Migration Certificate. (One set of photo copy along with all originals for verification).
- 2. Four colour passport size photographs and Two stamp size photographs.
- 3. Blood group Certificate.
- 4. Medical fitness Certificate.
- 5. Demand Draft of Rs. 33,400/- in favour of "BIJU PATNAIK UNIVERSITY OF TECHNOLOGY, ODISHA" payable at Rourkela.
- 6. JEE or GATE Rank Card.
- 7. JEE final allotment letter.
- 8. Residence Certificate.
- 9. SC/ST or OBC Certificate if any.
- 10. Undertaking for not to involve in any kind of job.
- 11. Undertaking and Affidavits of anti-ragging both for Student (Annexture I)and Parents(Annexture II). (Formats are given below.)

- This fee structure does not include Transportation and Hostel Fees.
- The total fee mentioned above is excluding the BPUT Registration Fee deposited by the candidates earlier at the time of document verification.
- The above fee structure may increase as per Govt. directives and the students have to pay accordingly.
