The University invites EOI without any consortium in sealed envelope from the reputed, professionally & financially sound and duly registered companies/ agencies/ organizations which have required experience in e-examination, Digital Evaluation, and (Pre- and Post Examination), Student On-Line Services and Remote Proctored On-line Computer/ Laptop / Android Based Mobile Examinations for any affiliating University or Universities to carry forward the existing e-examination system, digital evaluation, on-line remote proctored examinations (if pandemic situation continues) and services for the University.

Procedure for submission of EOI: Vendors proposing to submit EOI are advised to submit their proposals in a closed and sealed envelope super scribed with "EXPRESSION OF INTEREST FOR E-EXAMINATION" latest by 10<sup>th</sup> November, 2020 addressed to the Registrar, Biju Patnaik University of Technology, Chhend, Rourkela-15, Odisha by Speed Post only.

The EOI be submitted along with all supporting documents in compliance with the requirements of EOI. The companies will be short listed after details scrutiny by the designated Committee. The short listed parties will be required to present a demonstration regarding their expertise and experiences with additional services rendered to any affiliating university or universities.

The Final Tender document will be uploaded once the presentations are over in due course of time. A committee will finally scrutinize, and financial bids will be invited only from those who shall meet desired requirements strictly as per the tender requirement.

The University reserves the right to accept or reject any or all the EOIs / Tender at any stage of the process without assigning any reason. No correspondence in this regard shall be entertained.
